CURRENT [LEGISLATIVE] EVENTS



On top of the \$100 million the Legislature and Governor invested last session to increase access & quality to early childhood opportunities, they invested an additional \$30 million. Here are just a few details...

- \$25 million for Voluntary Pre-K Program
- \$2 million to support Parent Aware
- \$1 million for MN Reading Corps
- \$750,000 for YWCA early childhood job training
- \$500,000 for start-up grants for child care business in Greater MN
- \$430,000 for St. Cloud Early Learning pilot

This class meets DHS Licensing training requirements for both Sudden Unexpected Infant Death (SUID) and Abusive Head Trauma (AHT). Content includes recommendations to reduce Sudden Unexpected Infant Deaths (SUID) including SIDS, suffocation, and other sleep related infant deaths; safe sleep environments; MN Child Care regulations related to safe sleep; as well as symptoms and consequences of abusive head trauma, risk factors for abusive head trauma; strategies to use when stressed, angry or frustrated.

10:15am- 12:15 pm Active Supervision: Children with Special Needs

This class meets the Family Child Care provider annual supervision training requirement. This training curriculum will address best practices of active supervision in a family child care setting. This training curriculum will identify MN Rule 2 Licensing standards, National Association of Family Child Care standards, and best practices regarding supervision in inclusive family child care settings; examine and address supervision challenges experienced in an inclusive family child care program; examine and address chronic illness in an inclusive family child care program

- Training requirements state you must complete SUID/AHT and Active Supervision training annually. Annually means prior to or within the same **month (not date)** that you took the training the previous year.
- Doors Open at 7:30 with Registration and Fire Extinguisher Checks
- You can choose to attend one class or both
- Pre-registration is required and fees are non-refundable.
- Fire Extinguisher checks will be provided by Central Fire Protection for a fee and will be there until 8:15 a.m.
- 2 hours of MNCPD Approved training per class
