Child Care Unionization Vote is Final

The Bureau of Mediation Services announced on January 29th that a vote on the unionization of family child care by CCPT-AFSME was moving forward. SCLFCCA recognizes all licensed family child care providers as independent business owners. For this reason, SCLFCCA maintains a neutral stance, neither opposing nor supporting unions. SCLFCCA sent information to our members with links to both sides of the issue so members could form an educated decision in regards to their own businesses. The Bureau of Mediation Services ordered a union election for Minnesota licensed family child care providers. Some important points about this election:

- Ballots were mailed on February 5th to the 2,384 eligible voters as determined by the Department of Human Services according to correspondence with the Bureau of Mediation Services
- Both licensed and unlicensed providers who have current CCAP clients who received payment in December received a ballot
- The Union Election Ballots were counted on March 1st. The votes are in and are as follows: Total votes sent out: 2,348 Total votes received: 1,412 Total Votes for YES: 392

Total Votes for NO: 1,014

'No' votes were voting against the union and the 'Yes' votes counted to support the union.

Licensing Update

SCLFCCA is pleased to announce that licensors are again attending our board meetings the second Monday of the month (Sept-May). Please know, all SCLFCCA members are also welcome to attend these meetings held at the Klein Bank basement in Prior Lake, on Duluth Avenue from 7:00pm – 9:00pm.

Licensor Notes: We were reminded as of January 1st that a background study on a new person who would work in your family child care cannot work alone until the clearance letter has been received or the 15-day notice. If you have questions, please call licensing at 952-445-7751.

SUID and AHT training through Educare.com (Phyllis Porter) does NOT qualify for the required training. Several providers have done this online training, only to get to the end of the training to find out it does not qualify. Training on-line from Eager to Learn DOES qualify.

Licensing shared that there has been an increase in late paperwork when providers are renewing their license. They suggested if you have everything completed except for the consent or denial of parents for their email, to put a post-it note on that page and send it in separate as soon as you get the signatures so the other paperwork can be processed in a timely manner.
